

## Cookie policy

As of 5 June 2012, the cookie law came into force, as part of the Dutch Telecommunications Act. This provision means that websites must inform their visitors regarding their use of cookies.

### 1. Cookies

Zanders' website makes use of cookies. A cookie is a small file that is saved on the hard disk of your computer or mobile device. Such cookies serve to register information relating to your website visit.

### 2. Consent form

The information stored in the cookies is used exclusively by Zanders. Zanders does not make use of advertising networks and data are not shared with third parties. Zanders places third-party cookies only.

### 3. Types of cookies

There are several types of cookies. Zanders' website exclusively makes use of third-party cookies for Google Analytics and for social media.

#### • Google Analytics

This website makes use of third-party cookies for Google Analytics. The US company Google places a cookie through our website as part of its Analytics service. We use this service to monitor and gain insight into the way you use our website. Google may provide such information to third parties only in the event of mandatory disclosure, or insofar third parties process the information on behalf of Google. We have no degree of control in this issue. We have granted Google permission to use the Analytics information obtained for other Google services.

The information is transferred to Google and stored on servers in the United States. The information Google collects is anonymized as much as possible. This means that your IP address is not forwarded.

#### • Social media

This website makes use of the like and follow buttons of Facebook, Twitter and LinkedIn to promote Zanders' social networks and web pages. These buttons work based on codes that originate from Facebook, Twitter and LinkedIn. These codes serve to place cookies. We have no degree of control in this issue.

Zanders is not responsible for the privacy policy and use of cookies by these third parties. Read the privacy statement of Facebook and Twitter (these are subject to frequent changes) to read what they do with your data and private data processed via these cookies.

The information they collect is anonymized as much as possible. The information is transferred to Twitter, Facebook, Google+ and LinkedIn and stored on servers in the United States by these parties. Twitter, Facebook, Google+ and LinkedIn state that they comply with the Safe Harbor principles and are a member of the Safe Harbor program of the American Ministry of Trade. This means that an appropriate protection level for processing any private data is in place.

#### • Permanent cookies

A permanent cookie allows us to recognize you when you revisit the site. The website can be adjusted to your special preferences this way. If you have given us permission to place cookies, we can remember this by storing a cookie. This prevents you from having to repeat your preferences each time you visit, saving you time and ensuring a smoother experience on our website. Permanent cookies can be removed by editing your browser settings.

#### • Session cookies

Using session cookies allows us to see which sections of our website you used during your visit. This allows us to adjust our service to our visitors' surfing behavior as much as possible. Such cookies are automatically removed as soon as you close your browser.
